

TERM & CONDITIONS

1. Identification of the holder and general information SNAKE SUNGLASSES is the name of the company Royal Supernova SL. These Terms and Conditions govern the access and use of the web site www.snakesunglasses.com, owned by Royal Supernova SL. Torre de Benagalbon, Calle abrego 1, 3ºB, Rincon De La Victoria, B-93527778, as well as the services and products offered by SNAKE SUNGLASSES on their website. SNAKE SUNGLASSES allows the use of the Web site provided this is done in accordance with these Terms and Conditions. By visiting the website and using the services or applications of the Website, you agree to these Terms and Conditions. Access to the Web site will not require any registration from Users. Nevertheless, to purchase the services offered by SNAKE SUNGLASSES, you will be required to register the User and accept these conditions before proceeding to payment. These SNAKE SUNGLASSES Terms and Conditions, which will be described below, define the rights and obligations of SNAKE SUNGLASSES and Users in the context of the Website. These are the only Terms and Conditions applicable to the use of the Website (although they may The existence of special conditions for certain services) and the forwarding of orders through the Website, and shall supersede any other condition except in the prior written agreement between SNAKE SUNGLASSES and the User.

2. User Data In order to be able to purchase the products offered through the Website you will need to register by using the registration form on the Website. The User will be responsible for safeguarding the confidentiality of the data and information provided, as well as limiting access to your computer and access data to prevent unauthorized use. In the event that the User has reason to believe that his or her data has been disclosed to a third party, or that they have been used without prior authorization, or that there is a risk of doing so, he shall immediately inform SNAKE SUNGLASSES. 3. Sales Orders and Conditions The services and products offered through the SNAKE SUNGLASSES Web Site are intended for the purchase by Users of Sunglasses of the brand SNAKE SUNGLASSES. In order to submit an order to SNAKE SUNGLASSES, you must be at least 18 years of age. Through the www.snakesunglasses.com Web Site, SNAKE

SUNGLASSES will send merchandise to all over the world. To submit an order through the Website, you must provide a set of data before purchase through the appropriate form. This data will be needed to process the purchase order.

4. Price and Payment Methods Once you complete the form, you must pay for the order through one of the payment methods listed on the Website. Once the payment is made, the User will receive an e-mail message confirming the order. The message will include a summary of the items purchased, the sending mode requested, and the address of the recipient. If a problem arises at the time of payment, preventing the successful completion of the transaction, the User will receive an automatic payment error message and his order will not be forwarded until the payment process is successfully completed. Service prices are expressed in Euros (€). This includes fees and handling and shipping costs, the amount of which will be indicated upon the final confirmation of each order.

5. About SNAKE SUNGLASSES products and services The data included on the Website in each product or service description, photographs, graphic or iconographic representations or videos, as well as trade names, brands or distinctive signs of any kind have a purely informative function. SNAKE SUNGLASSES therefore declines any liability arising from errors in the above information, and undertakes to take all measures at its disposal to correct the errors or omissions as soon as possible after having been informed of them.

6. Returns and right of withdrawal 6.1 Returns due to manufacturing defects The User may return to SNAKE SUNGLASSES, at no extra charge, any product that has a factory defect within a maximum of 15 days. Returning products that have factory defects will not incur any additional costs for the User. To formalize the refund, you will need to contact SNAKE SUNGLASSES at the info@snakesunglasses.com e-mail address indicating the product or the products of your return and including a photograph and a detailed description of the defects found in them. If the return is relevant, within 3 to 5 business days, SNAKE SUNGLASSES will indicate to the Customer how to dispatch the defective product to its offices / warehouses. The shipping address for our warehouses is: Torre de Benagalbon, calle abrego 1 - Rincon De La Victoria. Each returned product must be in perfect condition (not used) and provided with all original labels, packaging and, if necessary, documentation and / or accessories. Otherwise SNAKE SUNGLASSES reserves the right to refuse the return. After receiving the product and verifying the defects, SNAKE SUNGLASSES will give the Customer the opportunity to replace the product with another

of the same characteristics, unless this option is objectively impossible or disproportionate for SNAKE SUNGLASSES. In the event that it is not possible to ship a product from the same characteristics due to the lack of stock, Customer may request reimbursement at no extra cost. In the event of a return, the delivery of the new product will be done within the next 3-5 working days counted from the date SNAKE SUNGLASSES confirms to the Customer the replacement of the defective product. If SNAKE SUNGLASSES has been selected, the amount of time required to repay the amount paid depends on the payment method chosen by the customer at the time of purchase: by credit / debit card, the amount will be refunded within 14 days , With PayPal, the amount will be refunded within 24-48 hours after SNAKE SUNGLASSES determines the validity of the yield.

6.2 Withdrawal

In the event that the User does not feel satisfied with the products received through the forwarded order, the Customer will have a term of fourteen (14) days in accordance with the General Law on Consumer Protection to return the totality of the " Order or, if you prefer, a part of the products constituting the total order. All this will be done without any penalties and without the need to indicate the reasons. However, the User will incur the direct return cost to SNAKE SUNGLASSES whether he decides to return the whole order if he decides to return only some of the order products. To formalize the refund, you must contact SNAKE SUNGLASSES at the e-mail address info@snakesunglasses.com, filling in and including the download form from these Terms and Conditions. Upon receipt of this communication, SNAKE SUNGLASSES will indicate the method of sending the order to its offices or warehouses. You can send the product to the following SNAKE SUNGLASSES bureaus: Torre de Benagalbon, calle abrego 1 - Rincon De La Victoria. SNAKE SUNGLASSES can not be held responsible for the courier company chosen by you for returning the order. In this regard, SNAKE SUNGLASSES recommends that the Customer request the company to issue a delivery note once the courier has deposited the product at the SNAKE SUNGLASSES offices / warehouses, so that the User can be placed / A to know that the product has been properly delivered. SNAKE SUNGLASSES, moreover, can not be held responsible if the Customer sends the order to an address that does not match those listed above.

Regarding User Returns within the European territory, SNAKE SUNGLASSES can not be held liable if the Customer sends the order to a domicile that does not match the SNAKE SUNGLASSES office: Torre de Benagalbon, calle abrego 1 - Rincon De La Victoria. Expenses resulting from the return of the order (such as shipping costs via courier companies) will be deducted directly from the User. The product will be returned unused
